

VACATION RENTAL GENERAL REQUIREMENTS

For all those who wish to rent a pitch or a Mobile-Home in our campsite and in order to have your renting available the very day of your arrival, you should keep in mind that all this is executed according to the specific dates and availabilities you should not miss :

While sending back your booking contract, you must join to it a deposit , which will actually be deducted from the total amount of your stay.

In order to avoid any sort of misunderstanding we would like to remember that :

- If you wish to rent a Mobile-Home, or a pitch you have to pay the total amount of your stay as soon as you arrive in our campsite
- All renting is exclusively private, you are not allowed to sublet or to leave your renting to a third party.
- Any alteration that could increase or reduce the total amount of the dues should be reported as soon as you arrive in the campsite. If there had been any false declaration, this contract can be terminated without any further refund.
- In the case you are late for the beginning of your stay and so as to keep your renting, you are to warn the campsite. If you have not done so in the 24 hours that follow your planned arrival, the manager is allowed to offer your renting to somebody else.
- If you decide to cancel your stay 30 days before your arrival in the campsite, 50 € (for a pitch), 120 € (for a Mobile-Home in high season) and 30 € (per night for a Mobile-Home in low season) will be deducted from your deposit amount. If you go beyond this limit, the manager is allowed to keep all the amount you have sent and you will have to pay the balance. In any case, the booking fees are retain.
- Once you have started your stay in the campsite and in the case you decide to anticipate your departure for whatever reason, you shall not be repaid the amount of your stay.
- Animals are welcome in the campsite (keep on a lead !), except inside the Mobile-Homes.
- It's forbidden to smoke inside our renting.
- Shorts are forbidden in the pool.
- Upon your arrival, you will be asked for a 400 € deposit per Mobile-Home, and 200 € deposit per Lagune, refundable upon departure if it's clean and nothing missing. You will find a clean and fully equipped renting, and you will be expected to hand it back in the same conditions.
- If we have to clean it for you when you are living, 50 € will be deducted from your deposit.
- You will also be asked for a 20 € deposit for the automatic-gate of the campsite. Refundable when you bring back the card.
- The attributive clause of jurisdiction : any dispute that could come up shall be exclusively be solved by the Magistrates' Court of Les Sables d'Olonnes.
- Please send us the copies of the Contract that you have filled and signed. As soon as we receive them, the manager will sign one of them and send it back to you to confirm the booking.

We remain thankful for your faithfulness, hope you will spend an unforgettable moment and enjoy your stay among us in "Le Bois Joli".
